# **TechSource Privacy Notice for California Consumers**

Effective Date: November 17, 2025

TechSource, Inc. ("TechSource," "we," "us," or "our") adopts this Privacy Notice to California Employees and Job Applicants Regarding the Collection of Personal Information (the "Privacy Notice") to comply with applicable laws, *e.g.*, the California Consumer Privacy Act ("CCPA") and California Privacy Rights Act ("CPRA"). TechSource is committed to protecting the privacy and security of your personal information. Please also know that TechSource does not sell your personal information.

The Privacy Notice applies only to individuals residing in the State of California who are considered "Consumers" under applicable laws and from whom we collect "Personal Information." We provide you with this notice because California Residents who are job applicants, employees, or contractors of a business qualify as Consumers. For purposes of this Privacy Notice, when we refer to Consumers, we mean you to the extent you are a California employee, employee applicant, or contractor.

#### Information we collect

We may collect Personal Information from you in a variety of different situations, including, but not limited to on our website, through email, in physical locations, through the mail, and/or over the telephone. More specifically, TechSource may collect the following categories of Personal Information from California job applicants, employees, or contractors, which will depend on the particular Business Purpose (described in the How We Use Personal Information below) for which we collect it:

Category	Examples of Personal Information that May Be Collected
A. Identifiers.	A real name, alias, postal address, unique personal identifier, online identifier, Internet Protocol address, email address, account name, Social Security number, driver's license number, or passport number.
B. Personal information categories listed in the California Customer Records statute (Cal. Civ. Code § 1798.80(e)).	A name, signature, Social Security number, physical characteristics or description, address, telephone number, passport number, driver's license or state identification card number, insurance policy number, education, employment, employment history, bank account number, medical information, or health insurance information.

C. Protected classification characteristics under California or federal law.	Age, race, color, citizenship, marital status, medical condition, physical or mental disability, sex (including gender, gender identity, gender expression, pregnancy or childbirth and related medical conditions), veteran or military status.
D. Commercial information.	None.
E. Biometric information.	None.
F. Internet or other similar network activity.	Browsing history, search history, information on a consumer's interaction with a website, application.
G. Geolocation data.	Physical location.
H. Sensory data.	Audio.
I. Professional or employment-related information.	Current or past job history or performance evaluations.
J. Education information, as defined by the Family Educational Rights and Privacy Act	None.
K. Inferences drawn from other personal information.	Profile reflecting a person's preferences, characteristics, predispositions, behavior, attitudes, or abilities.

Personal information does not include de-identified or aggregated consumer information.

TechSource obtains the categories of Personal Information listed above from the following categories of sources:

- Directly from you. For example, from forms you complete or services we provide you.
- Indirectly from you. For example, from observing your actions on our website or from information
  your computer or mobile device transmits when interacting with our website or mobile applications,
  among other things.
- Third parties, including recruiters who submit your information to us for an employment position that may interest you, and consumer reporting agencies for employment background and drug screens.

#### **How We Use Personal Information**

We may use or disclose the Personal Information we collect from you or about you to do one or more of the following business purposes:

• To fulfill or meet the purpose for which you provided the information. For example, if you share your name and contact information to apply for a job or become an employee, we will use that personal information in connection with your employment or potential employment.

- To contact you and to inform you about benefits or information relating to your employment or potential employment.
- To provide, support, personalize, and develop our website and services relating to your employment or potential employment.
- To create, maintain, customize, and secure your information or account with us.
- To process your requests or transactions and prevent transactional fraud.
- To provide you with support and to respond to your inquiries, including to investigate and address your concerns and monitor and improve our responses.
- To help maintain the safety, security, and integrity of our systems, Website, services, databases and other technology assets, and business.
- For research, analysis, and business development, including to develop and improve our business processes, Website and services.
- To respond to law enforcement requests and as required by applicable law, court order, or governmental regulations.
- As described to you when collecting your personal information or subsequently agreed to by you.
- To evaluate or conduct a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of TechSource's assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which Personal Information held by TechSource about our Consumers is among the assets transferred.

We will retain the personal information described above for as long as necessary to fulfill the purpose for which it was collected, or as required by applicable laws or regulation.

### How we share personal information

TechSource may disclose your Personal Information to a third party for a business purpose, including to our service providers.

We disclose and share your personal information with the following categories of third parties:

- Service providers.
- Third parties with whom you direct us to share your personal information.
- Third parties as part of our employment process such as consumer reporting agencies for employment background checks.

Other California privacy rights

California's "Shine the Light" law (Civil Code Section § 1798.83) permits users of our website that are California residents to request certain information regarding our disclosure of Personal Information to third parties for their direct marketing purposes. Please know, however, that TechSource does not disclose your

Personal Information to third parties for their direct marketing purposes.
